

Halesi Tuwachung Municipality Office of the Municipal Executive Durchim, Khotang Invitation for Bids First date of notice publication: November 25, 2019 (Mangsir 9, 2076)

- The Government of Nepal [GoN] in collaboration with Nepal Oil corporation has allocated funds towards the cost of Construction of Halesi Tuwachung Dharmashala Building (RCC framed Structure) at Halesi Tuwachung Municipality-07, Khotang (Contract No: 03/HTM/KHOTANG/076-077). Bidding is open to all eligible bidders as per Section V of Bidding Document
- 2. The *Office of the Municipal Executive, Durchim, khotang* invites sealed bids submitted electronically from registered contractors for the construction of Halesi Tuwachung Dharmashala building under National competitive Bidding- single stage two envelop bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- i. Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: NRs. 50 Million
- ii. Minimum Work experience of similar size and nature: At least One (1) RCC framed structure building project within the last
- ten (10) years, with a value of at least Nrs 45 Million of similar size and nature.
- 3. Bidder must submit their bid electronically upon payment of a non-refundable fee of NRs.5000.00 till 24 December-2019, 12:00 hours and download the bidding documents for e-submission from PPMO's e-GP system www. bolpatra.gov.np/egp. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document
 - I. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of Municiple Executive, Durchim, Khotang, Nepal or may visit PPMO e-GP system www.bolpatra.gov.np/egp.
- 5. Pre-bid meeting shall be held at the Office of the Municipal Executive, Durchim, khotang at 13:00 hrs on December 17, 2019 (Mangsir 29, 2076)
- 6. Electronic bids must be submitted to the *Office of the Municipal Executive, Durchim, khotang* by through PPMO's e-GP system www.bolpatra.gov.np egp on or before 12:00 hrs on December 24, 2019 (Poush 8, 2076). Bids received after this deadline shall not be accepted. The bids shall be opened physically in the presence of Bidders' representatives who choose to attend at 14:00 hrs on the same day at same place.
- 7. Bids must be valid for a period stated in the table and must be accompanied by a bid security amounting to a minimum of as mentioned in the table below. The bid security shall be valid for 30 days beyond the validity period of the bid. Information regarding the Bid Security deposit in the Bank;
